Transition to ICD10 continues with collaboration with participants in the local RHIO and EMR vendors. Webinars have been scheduled – the first of which will be held on June 17, a copy of the flyer is attached to this report.

In compliance with the request of Doctor Maldonado at the Council meeting immediately following the HOD, an analysis of *all* groups membership status is being undertaken in both Erie and Chautauqua counties. The analysis will include the total physicians in a group and County/MSSNY membership penetration. For non-members in a given group, the analysis will differentiate between former and non-members and will include the age (if available) of those non-member physicians. Upon completion, plans call for the development of marketing pieces directed specifically to the specialty of that group.

The AMA has launched an aggressive membership campaign directly to the Deans of Medical Schools. A copy of their marketing piece (attached) was forwarded to Ms. Nadolny. It appears that this outreach is considered to be attractive by UB, the membership threshold is minimal-6 academic leaders (1 of which is Dean) for a 20% reduction in dues and offers an opportunity for those physicians who are involved in academics. The attached flyer has been previously sent to Mr. Schuh and Ms. Skelly for further discussion.

At this time, I would like to ask the Council to direct the membership committee to establish a similar category of membership for those physicians in academic leadership positions.
