- É The Society Annual Meeting was held on Tuesday, June 7, 2016. Prior to the meeting, President Elect Matthew Bonanno, MD accepted a postion out of state, and so is unable to serve his term. Subsequently, the Society Nominating Committee asked Doctor Michael Goldstein if he would accept a second term as president. He agreed to do so, becoming the first New York County Medical Society president in over a hundred years to serve two terms. The members were appreciative and thanked Doctor Goldstein at the Annual Meeting, which included guests from MSSNY and the other boroughs.
- É The Society continues to focus on membership by providing assistance to help members with their practice needs. On Septembe 7, members can attend a webinar that provides assistance with HIPAA issues, including how to resolve HIPAA requirements with MACRA. In addition, members also got a stepóbyóstep reference booklet to answer MACRA questions. - É In June, the Society held its annual meeting with Assembly Health Committee Chair Richard N. Gottfried. Leadership discussed issues of concern to Manhattan physicians about network issues, eóprescribing, and retail clinics, among others.
- \acute{E} The Society continues to work on benefits for members and is exploring promotions with shredding and storage, disposal, and billing, among others.
- É The Society is working with the Touro College of Osteopathic Medicine on a number of joint CME opportunities, including a program on anatomy and manipulation at Touro on October 18.
- É The membership was urged over the summer to contact the Governor asking him to sign legislation related to eóprescribing.
- É The Society hosted a meeting on tax planning in June, and will continue quarterly programs on financial planning concerns for members.
- É The Society is working with MSSNY & Membership Department on new member recruitment possibilities in Manhattan through Facebook marketing.
- É At its Board meeting on September 12, the leadership will review issues related to MLMIC¢s proposed sale to Berkshire Hathaway.
