

MSSNYPAC REPORT TO THE MSSNY COUNCIL

This report reflects the financial status of MSSNYPAC during the 2017 first quarter dues collection period of 8/1/16 through 10/25/16. We collected \$52,025.02 from 354 contributors. Each dollar contributed to MSSNYPAC is split between operating expenses and contributions to candidates in a ratio of 2:8. In comparison to the same period the previous year, 8/1/15 through 10/25/15, we collected \$43,247.24 from 360 contributors. With the elections coming up and our PAC receiving unprecedented requests for support in these many contested elections, our balance has dwindled significantly.

MSSNYPAC would like to thank Dr. Thomas Lee and Dr. Michael Brisman for their efforts to organize a physician event with MSSNYPAC support for the Senate Republican Campaign Committee. We would also like to thank the many physicians who take time away from their personal lives to attend political events as representatives of MSSNYPAC.

During the 2016 House of Delegates, MSSNYPAC's Executive Committee created the President's Circle for those who contribute \$2,500 or more annually. The President's Circle currently has 12 supporters and the Chairman's Club currently has 72 members who are listed below.
