The Medical Society County of St. Lawrence has requested that life membership status be granted to **Melchiorre Buscemi, MD** as Dr. Buscemi has retired from the practice of medicine.

MSSNY's records indicate that Dr. Buscemi has been a member of the MSSNY since September 21, 1993. Dr. Buscemi was dropped for non-payment of dues on May 1, 2018. Dr. Buscemi's dues were being paid for by an agreement with Massena Memorial Hospital. In 2018 they stopped paying MSSNY dues for Dr. Buscemi and due to a clerical billing error, Dr. Buscemi was never billed for his 2018 dues and therefore had a break in his MSSNY membership.

Inasmuch as Dr. Buscemi, born on September 21, 1954, is now sixty-seven years of age and has been a member for over twenty-eight years, the Medical Society County of St. Lawrence requests that Dr. Buscemi be granted life membership status.
