SUBJECT: PUBLIC HEALTH AND EDUCATION REPORT

The following is an update on various projects that MSSNY's Division of Public Health and Education are involved in and occurred over the last year.

MSSNY Practice Transformation Initiative

The Medical Society of the State of New York is collaborating with the Physicians Foundation and American Medical Association to advance research and promote evidence-based solutions that improve patient care by enhancing professional well-being and reducing physician burnout. During the height of the COVID-19 pandemic, MSSNY became involved in the American Medical Association (AMA) and the Physicians Foundation's Practice Transformation Initiative to help physicians and institutions reduce physician burnout by implementing evidence-based solutions, and best practices within the organization. This national initiative has helped various New York State institutions assess the wellness of physicians within the institutions and practices and then implement an intervention and then reassess well-being a year after the implementation of the intervention. Currently, MSSNY has joined with the following institutions on this PTI project: Bassett Healthcare, Ellis Medicine, Northwell Healthcare, St. Peter's Partners, and NY Presbyterian/Brooklyn.

Today, all six practice sites have administered and closed a mini-z assessment surveys amidst the COVID-19 surges and have implemented various practice interventions tailored to specific results. Each practice site was invited to attend various educational webinars in which the AMA hosted professional personal for various topics such as pre-visit planning/labs. Currently, the practice sites will be deploying post- mini-z assessment surveys which will aim to measure overall change of workplace satisfaction after each practice implemented these interventions. Given the surge of the DELTA variant, some of the practice sites will be opting to postpone their post- mini-z survey until the end of fall/beginning of winter.

MSSNY Telehealth Initiative

In August 2021, MSSNY, the AMA and the Physicians Foundation also agreed to work together to develop relevant educational content, resources, measurement tools, and evaluation support to help practices with telehealth implementation. MSSNY, as part of this program, will be part of a national network and support needed to establish and

maintain strong relationships with physicians, practices, and health systems interested in implementing, optimizing, or sustaining telehealth. In addition to providing ongoing support, this year's program will emphasize the importance of realizing the true value of virtual care. MSSNY has signed four letters of agreement with: Eger Health Care and Rehabilitation Center, Northwell Health-TeleHealth Emergency Medicine, C DOC Medical Group PLLC, and Mount Sinai NOW Emergency Medicine. We are actively pursuing at least two more practices. MSSNY is much further ahead in this process than other states. Both the PTI and the TTI are led by MSSNY's Cayla Lauder.

MSSNY Joint Organizational Meeting on COVID 19 Vaccines

At the request of the New York State Department of Health, a joint organizational meeting on COVID-19 vaccines, has been convened by the Medical Society of the State of New York. This group is comprised of MSSNY, various medical specialties, county medical societies executives, the New York State Association of County Health Officials (NYSACHO), local county health commissioners, and officials from the New York State Department of Health. The purpose of this group is to help facilitate and promote COVID19 immunizations, ensures vaccine equity and assist with any distribution of COVID19 vaccine. MSSNY is also assisting the NYS DOH in promoting enrollment into the COVID19 vaccination program. As the Biden Administration begins immunization of children 5-11 years of age and needs the assistance of pediatricians and family physicians to provide this immunization to children. There is also a need for more physician practices to provide the booster to those adults who are eligible. MSSNY is encouraging physicians to become enrolled in this program. Physician Wellness-- MSSNY Peer to Peer (P2P) Program

MSSNY's P2P has over 50 peer supporters that underwent training to assist their colleagues who are need of help in dealing with work and family stressors. With the advent of the COVID-19 pandemic, some of the emotional issues related to this event, may also be troubling for our colleagues. The program is offered to physicians, residents and medical students and is a completely confidential and anonymous opportunity to talk with a peer about some of life stressors. Under the direction of the MSSNY's Physician Wellness and Resiliency Committee the program has established a confidential helpline phone number (1-844-P2P-PEER) and an email address (p2p@mssny.org) so that physicians may be connected with a peer 24 hours a day/7 days a week. It is anticipated that there will be refresher training, training on specific topics and training of new peers in 2022. Additionally, MSSNY has sent a survey to all peer supporters regarding what type training receive, stressors that they themselves had during the pandemic, etc. Cayla Lauder serves as the program coordinator for this program and can be reached at clauder@mssny.org.

MSSNY Emergency Preparedness and Disaster and Terrorism Response Committee

This committee has been actively involved in helping to educate hundreds of physicians and other healthcare providers throughout the course of the pandemic. MSSNY began its 19th year of its partnership with the New York State Department of Health in July 2021 and conducted a program at the MSSNY House of Delegates. Under Medical Matters, "Influenza in the Age of COVID19" was conducted by webinar. Medical Matters will conduct **Psychosocial and Epidemiological Aspects of Vaccine Hesitancy" on Wednesday November 17, 2021 at 7:30 a.m.** William Valenti, MD, chair of MSSNY Infectious Disease Committee and a member of the Emergency Preparedness and Disaster/Terrorism Response Committee and Craig Katz, MD, vice-chair of the Emergency

Preparedness and Disaster/Terrorism Response Committee will serve as faculty for this program.
