#### 1. President's Report

a) MSSNY AD HOC Scope of Practice Committee

**AMENDED & ADOPTED** Resolution 112-2020

(additions bolded & underlined)

Allow Anesthesiology Assistants to be Licensed in NYS

RESOLVED, that the Medical Society of the State of New York <u>advocate for legislation and</u> with the New York State Department of Education to license and regulate Certified Anesthesiology Assistants <u>working under the direct supervision of physician</u> <u>anesthesiologists</u> in the State of New York.

b) <u>Committee on Emergency Preparedness and Disaster and Terrorism Response</u> Committee on Infectious Diseases

**ADOPTED**, the Proposed MSSNY COVID-19 Resolution

RESOLVED, that the Medical Society of the State of New York strongly advocate for mandatory COVID-19 vaccination among all healthcare workers and support staff who regularly interface with the public, and be it further

RESOLVED, that the Medical Society of the State of New York strongly advocate for mandatory COVID-19 vaccination among all school-aged children, once the Centers for Disease Control and Prevention (CDC) and Food and Drug Administration (FDA) confirm the safety and efficacy of the COVID-19 vaccines in the pediatric population, and be it further

RESOLVED, that for the duration of the COVID-19 pandemic and based upon the recommendations of the CDC and/or the New York State Department of Health, that the Medical Society of the State of New York strongly advocate for mandatory facial masking among all healthcare workers and support staff who regularly interface with the public, as well as all students, teachers, and administrative and support personnel in all primary, secondary, and postsecondary educational facilities in New York State.

#### c) 2021 House of Delegates Resolutions Referred to Council

**ADOPTED,** the 2021 House of Delegates Resolutions to the appropriate committees of jurisdiction. The Council **AGREED** to refer Resolution 2020-2 MSSNY Council Representation to the House Committee on Bylaws with input from relevant Committees on Long Range Planning and Development, Strategic Planning and Membership

2. **Board of Trustees Report** – Presented by Dr. Arthur Fougner A virtual meeting of the MSSNY Board of Trustees was held on Wednesday, September 22, 2021, at 7:00 p.m.

The Council **APPROVED** the following action items:

- The Board approved the Minutes from the Board of Trustees meeting held on June 2, 2021.
- The Board approved the continuation of the MSSNY Dues Commission Program for the 2022 dues year.
- The Board chose Impexium as the company to implement the upgrade and restructure of MSSNY's database and website. Negotiations will continue and MSSNY will engage Garfunkel Wild to prepare the final contract.
- 3. <u>Secretary's Report</u> Presented by Dr. Frank Dowling **APPROVED**, unanimously the following:
  - Life Membership for thirty-one (31) physicians
  - Dues Remissions for five (5) physicians due to financial hardship
- 4. <u>MLMIC Update</u> Dr. John Lombardo thanked MSSNY staff for their hard work on the House of Delegates.
- 5. <u>AMA Delegation Report</u> Dr. Charles Rothberg reported that the AMA is pursuing relief of the pending Medicare cuts. The new class of delegates & alternates were elected and will be installed in 2022. The virtual AMA Interim Meeting is scheduled on November 12-16, 2021. The deadline for AMA resolutions is October 13.
- 6. MSSNYPAC Report Dr. Thomas Lee reported that the report reflects the financial status during the period of 1/1/21-9/22/21. MSSNYPAC thanks all the donors who participated in the past year. The collections from the virtual HOD totaled \$30,000. Dr. Lee thanked the county medical societies for their donations to MSSNYPAC.
- 7. County Federation Report Dr. Aaron Kumar welcomed Heather Lopez, the Vice President of Physician Payment & Practice and Valerie Cammiso, Vice President of Membership Services. He thanked Stav Savelidis, Executive Director of Nassau County for her efforts in planning the Executive Directors Conference that was postponed due to the cancellation of MSSNY's HOD. Dr. Kumar thanked Mr. Oechsner for involving the counties with MSSNY's new database and his continuous involvement with the Federation.

#### D. Reports of Officers

1. Office of the President – Joseph R. Sellers, MD

Dr. Sellers reported that he and Mr. Oechsner have been working on an Update on MSSNY Goals & Measures within the divisions of MSSNY. Dr. Sellers reported that he is looking into increasing non-dues revenue by looking into various grants. We are looking to get support for enhancing the ability of physicians to participate in telemedicine. He reported that new benefits had been added by the Member Benefits Committee and that it would continue working to identify additional benefits. We are working to improve our data management and our webpage. Dr. Sellers reported that he has had a great deal of exposure in the media representing MSSNY. Lastly, Dr. Sellers reported that he had a request from one of the councilors that if we are continuing to have virtual meetings would it be possible to hold future virtual meetings in the evening. Dr. Sellers recommended that all the members of the Council send suggestions via email to him & Mr. Oechsner and they will get back to the Council in November.

#### 2. Office of the President-Elect – Parag H. Mehta, MD

Dr. Mehta thanked Dr. Sellers for doing a phenomenal job keeping everyone together. He also thanked MSSNY staff for their long hours and hard work to select a vendor to improve our database. MSSNY has a tremendous staff helping us and guiding us to achieve our mission. Dr. Mehta reported that he had attended an event for Governor Cuomo and attended several other events on behalf of Kings County supporting political leaders. Dr. Mehta mentioned that this is women in medicine month, and we honor all the women who have offered their time and support.

#### 3. Office of the Vice-President – Paul A. Pipia, MD

Dr. Pipia thanked the speakers for a great job in preparing for the HOD and all those who attended. He thanked Dr. Sellers for the information that he is learning about the Office of the Presidents call.
