## <u>Meeting</u>

The Special Meeting of the Member of the Foundation was called to order. The sole action item on the agenda was whether to adopt a proposed change to the Foundation bylaws. The text of the proposed change is in **bold underline** below:

ARTICLE III. BOARD OF DIRECTORS. Section 3. Election.

(a) The Member shall elect members to the Board Directors each year at the annual meeting of the Member from a slate of candidates nominated by the Board of Directors or by the Member.

Twenty-seven voting MSSNY Council members attended the Special Meeting. This constituted a quorum which permitted the MSSNY Council to conduct the meeting and have a definitive vote on the issue.

The Councilors heard from MSSNY outside counsel, Jennifer Abelaj, who noted that the proposed Foundation Bylaws change is perfectly legal. In fact, Ms. Abelaj noted, it is quite common for the sole member of other non-profit foundations to select from the member's own list of candidates, not restricted to a list of candidates provided by the foundation board. Councilors asked questions and made statements both in favor and opposed to the proposed Bylaws change.

After continued debate, a motion was made and seconded to stop discussion and call the question. The vote to stop discussion and call the question was 16 in favor and 8 opposed. As such, a majority supported closing debate and calling the question to vote.

Once the question was called, the vote on the merits of the proposed amendment to Foundation Bylaws was 15 in favor and 10 opposed.<sup>2</sup> Accordingly, a majority supported amending Foundation Bylaws as proposed. The Foundation Bylaws change was therefore adopted by the Member and the Foundation Bylaws are amended as proposed.

The meeting was thereafter adjourned.
