MSSNYPAC REPORT TO THE MSSNY COUNCIL

This report reflects the financial status of MSSNYPAC during the 2022 fiscal year period of 1/1/22 through 6/22/22. We have collected \$96,170.75 from 306 individual supporters. Each dollar contributed to MSSNYPAC is split between operating expenses and contributions to candidates in a ratio of 2:8. For comparison, prior year collections for the same time period are as follows:

2021: \$78,704.14 from 240 supporters. 2020: \$59,109.49 from 204 supporters. 2019: \$140,043.52 from 423 supporters. 2018: \$148,749.46 from 480 supporters.

Political and Legislative Background:

As leader of the Senate Democratic Conference, Senator Stewart-Cousins oversees the management of the Senate and a Conference that has a 2-1 D-R majority. Their conference has been supportive of many issues raised by the physician community working together with patient advocacy groups that passed this year. The NYS Senate passed legislation to help reduce excessive hassles our patients experience in seeking to obtain needed health care treatment and prescription medications. These include bills that: eliminate health insurer-imposed "fail first" requirements for medications to treat patient mental health conditions; ensure patients can realize the full benefit of discount programs to meet their out of pocket maximum insurance requirements; reduce to 45 the age when health insurers must cover recommended essential colorectal cancer screening tests; and ensure that health insurers may not deny needed patient care unless the treatment is reviewed by a physician trained in the same or similar specialty as the physician providing patient care (long a MSSNY policy goal). Moreover, as part of this year's Budget, the Senate helped enact MSSNY-backed legislation to enact telehealth payment parity and significantly increasing funding for physician student loan repayment programs, as well as rejecting huge new costs that could have been imposed on physicians enrolled in the Excess Medical Malpractice. Importantly, their health care policy staff regularly seeks the perspective of MSSNY on numerous legislative proposals that impact health care delivery.

Their record is of course not perfect. Several objectionable items also passed the State Legislature this year over the objection of MSSNY and the allies MSSNY worked with on each of these issues, for which MSSNY is requesting vetoes. However, it is anticipated that Democrats will once again have a sizable majority in the NYS Senate in the 2023 Legislative Session, and that Senator Stewart-Cousins will continue to be the leader of the Senate. Therefore, it is imperative that the physician community work to enhance the relationship with her and other Senate Democratic leaders.

Campaign Finance Regulations:

Political donations from Individuals, Partnership and PACs to the Senator's campaign are limited to \$11,800 towards the General Election and an additional \$7500 towards a Primary Election. Corporation, LLC and LLP contributions are limited to \$5000 aggregate annually to races in NYS. All <u>LLC/PLLC</u> contributions must identify the members and percentage of ownership interests. Partnerships that make an aggregate contribution exceeding \$2500 will be required to identify each partner who is responsible for the contribution and the amount to be allocated to the partner(s). Attributions will count towards the owner/partner individual contribution limit. Political contributions are not tax deductible.
